

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community. Situated on the west side of a main road connecting Southville with Southborough north of the old toll road, now Route 9, this stone cottage is unique for its use of materials. There are a few other important stone houses in Southborough, but this is one of only two or three modest cottages built of stone from the area in this later ca. 1936 time period. The house sits back from the road raised slightly on a terrace with stone retaining wall. The side gable dwelling displays four bays that are not symmetrically placed on the main facade. The paneled door with wood storm door is set into the stone in a plain wood frame. On one side is a single window and on the other two windows. The 10 light-by-10 light wood casement windows also are set into the stone facade. The cottage is two bays deep with similar casement windows and one smaller window in the gable peaks. The wall surface of each of the gable peaks has wood shingled sheathing. The stone chimney is centered on the ridge. There is a slight overhang with no adornment of the eave edges of the roof. The stone garage (MHC #328) built at the edge of the road with paired carriage shed doors was constructed to replace the tiny one-car garage built into the slope of land just behind the house. The new stone garage was built ca. 1950.

Parkerville Road was the main connection from Southville north to the old toll road and Southborough Center from the early 1800s. Scattered farmsteads dotted the landscape with at least three Ward properties on Parkerville, Gilmore and Middle Roads just south of this property. The land for this property was part of the early twentieth century John A. Flanders farm and was that part called the Braithwait land for which Flanders, a farmer, was assessed. Throughout the 1920s he was assessed for 17 acres, 34, 573 square feet and in 1936 he was assessed for 16 acres, 20,383 square feet after he and his wife Kristinia Flanders had given this 1 acre, 14,190 square feet to their niece, Eleanor Dando, and her husband, Thomas Dando. Thomas Dando built this house for his wife using local stone and his own design to be similar to stone houses in Strathaven, Scotland where he had been raised. He started with the north end of the house and ended with the garages. In 1941 Eleanor Dando was assessed for the house and greenhouse and by 1947 the tiny one-car garage had been added at the end of the dirt driveway and built into the slope of the land. In the early 1950s Dando built the two-car garage with the help of his son in anticipation of needing additional space for his son's car after college. In the late 1940s Dando purchased some of the adjacent land from the Boston & Worcester Street Railway, the abutments (MHC #937) of which remain just north of this property at the former Parkerville Road crossing as evidence of this early twentieth century mode of transportation. Only scattered residential development occurred until the mid 1900s so that this is one of the few examples of construction from the 1920s to the 1950s in the southern part of Southborough and it is the only stone building from that period. Today much of the farm land along Parkerville Road has been subdivided into small house lots with large 1990s and 2000 new housing.

The property retains integrity of location, design, setting, materials, workmanship, association and feeling.
