

## QUITCLAIM DEED

Cleary Revocable Trust, a New Hampshire trust created under agreement dated January 25, 1991, with a mailing address of 33 Bunker Hill Road, Auburn, County of Rockingham, State of New Hampshire 03032, with QUITCLAIM COVENANTS:

A certain tract of land with buildings thereon situate in said Auburn, bounded and described as follows, To Wit,

Beginning on a highway leading from the Richard Hall place, so called, now or formerly owned by Fred C. Stacy to the Hazen Davis place, so called, now or formerly owned by one Noll, being commonly called the Bunker Hill Road at the corner of the land now or formerly owned by the said Fred C. Stacy; thence southeasterly by said Highway (15) fifteen rods to a stake and stones at the corner of land formerly owned by Edward C. Griffin and now or formerly owned by Carl C.
