To the extent that the location of any pool equipment, HVAC systems and equipment, or any other similar equipment or improvements appurtenant to a Unit or

structure shall encroach on any setbacks, such encroachments shall be deemed approved by the Association for purposes of compliance with this Section provided that they have been approved by Lee County or other applicable governmental entity or regulatory agency.
