THE BRAFFIELD HOMEOWNERS' ASSOCIATION, INTERECTIVE

The undersigned, being of the age of eighteen years or more, does hereby make and ma Articles of Incorporation for the purpose of forming a nonprofit corporation under and by virtue of the laws of the State of North Carolina,

- 1. The name of the dorporation is The Bracfield Homeowners' Association, Inc.
- 2. The corporation shall be perpetual in duration.
- The purpose for which the corporation is organized is to promote and develop the common good and social welfare of residents of the community known as the Bracfield subdivision in Union County, North Carolina
- 4. Every person who is a record owner of any lot is entitled to membership and voting rights in the corporation. Membership is appurtenant to, and inseparable from, the ownership of the lot. Multiple owners of one lot shall be considered one member
- The directors of the corporation shall be elected by the members in the manner and for the 5. terms provided in the Bylaws.
- No part of the net chrimes of the corporation shall mure to the benefit of any officer, director, or member of the corporation; and upon dissolution of the corporation the assets thereof shall, after all of its habilities and obligations have been discharged or adequate provision made therefor, be distributed to any association or associations organized for purposes similar to those set forth in Paragraph 3 hereinabove, all as more particularly provided in the Bylaws of the corporation.
- Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
- Amendment of these Articles of Incorporation shall require the affirmative vote of at leastthreefourths of the members
- ŋ Annexation of additional properties, merger and consolidation, mortgaging of the Common Area, or dissolution or amendment of these Articles shall require prior approval of HUD/VA for so long as there is a Class B Member (as that term is defined in the Covenants Conditions and Restrictions for Cedar Lanc Farms Subdivision)
