RESTRICTIVE COVENANT

We, the undersigned, being the legal owners of real property hereinafter described, do hereby consent to the improvement of streets bordering said property. In consideration of not being required to improve the said road at this time, we hereby expressly waive any and all right to remonstrate against the improvement of such streets in accordance with the City Street Improvement Standards for a residential street in effect at the time of the improvement, by the City of Hillsboro, Oregon, and the said assessment of such costs thereof against said property.

This consent, and waiver to remonstrate, shall expire twenty years from the date hereof but owners shall renew this covenant and extend same for an additional twenty years upon request of the City of Hillsboro.

The property subject to this consent and waiver of remonstrance is described as follows:

Lots 1, 27, 28, and 29, OLYMPIC PARK

It is hereby intended that this consent to, and waiver of remonstrate against, the said street improvements by the City of Hillsboro shall be binding on ourselves and all subsequent owners of the hereinabove described property and shall run with title to the said property.
