Improper installation of clothes washer lead to drain pipe water issue. The small affected area was opened, dried, and repaired. No issues since.

The water heater failed in 2025 the small affected area was opened, dried, repaired, and a new unit installed.

Minor moisture from a couple window-caulking gaps led to small siding sections being replaced and recaulked.
