LEGAL DESCRIPTION:

PARCEL "A"
 STARTING AT THE SOUTHEAST CORNER OF LOT 1, HERRON'S SUBDIVISION NO. 9, AS RECORDED IN PINELAS COUNTY PLAT BOOK 23, PAGE 28, RUN THENCE ALONG THE SOUTH LINE OF SAID LOT 1 NORTH $89^{\circ}58'00''$ WEST 28.36 FEET FOR A POINT OF BEGINNING. CONTINUE THENCE ALONG THE SOUTH LINE OF SAID LOT 1 EXTENDED NORTH $89^{\circ}58'00''$ WEST 205.84 FEET MORE OR LESS TO A POINT OF INTERSECTION WITH THE MEAN HIGH TIDE LINE OF THE GULF OF MEXICO; RETURNING TO THE POINT OF BEGINNING, RUN THENCE SOUTH $81^{\circ}29'56''$ WEST 202.85 FEET MORE OR LESS TO A POINT OF INTERSECTION WITH THE MEAN HIGH TIDE LINE OF THE GULF OF MEXICO; RUN THENCE NORTHWESTERLY ALONG THE MEAN HIGH TIDE LINE OF THE GULF OF MEXICO TO THE AFOREMENTIONED POINT OF INTERSECTION. ALL LYING AND BEING IN GOVERNMENT LOT 3, SECTION 25, TOWNSHIP 31 SOUTH, RANGE 15 EAST, PINELAS COUNTY, FLORIDA.

PARCEL "B"
 LOT 1, HERRON'S SUBDIVISION NO. 9, AS RECORDED IN PLAT BOOK 23, PAGE 28, OF THE OFFICIAL RECORDS OF PINELAS COUNTY, LESS THAT PART OF LOT 1 LYING IN THE FOLLOWING DESCRIBED TRACT. FROM A POINT OF BEGINNING AT THE NORTHEAST CORNER OF SAID LOT 1, RUN SOUTH $81^{\circ}19'25''$ WEST TO THE HIGH WATER MARK OF THE GULF OF MEXICO, FOR A POINT "A"; RETURN TO THE POINT OF BEGINNING; RUN THENCE NORTH $89^{\circ}58'00''$ WEST ALONG THE NORTH LINE OF SAID LOT 1 TO THE HIGH WATER MARK OF THE GULF OF MEXICO; THENCE SOUTHEASTERLY ALONG SAID HIGH WATER MARK TO POINT "A". 
