Thence with the South boundary line of reference tract and North Right-of-way line of said road, in curve to the left, concave to the Southeast, having a radius of 5769.58 feet, a central angle of 5°58'52", a long chord of S39°06'32"W - 602.01 feet, at an arc distance of 602.29 feet, the end of said curve, a ½ in. iron rod set for corner, from which a ½ in. iron pipe with cap stamped 'MGP 4527' found bears S53°52'54"E - 80.00 feet;

Thence S36°12'44"W, at a distance of 404.57 feet, continuing with the South boundary line of reference tract and said North Right-of-way, to the Southeast corner of 'Reserve Area A' of Union Oaks Subdivision, Revised, recorded in the Map and Plat Records of Angelina County, Texas in Cabinet I on Slide 15B,a ½ in. iron pipe with plastic maroon cap found for

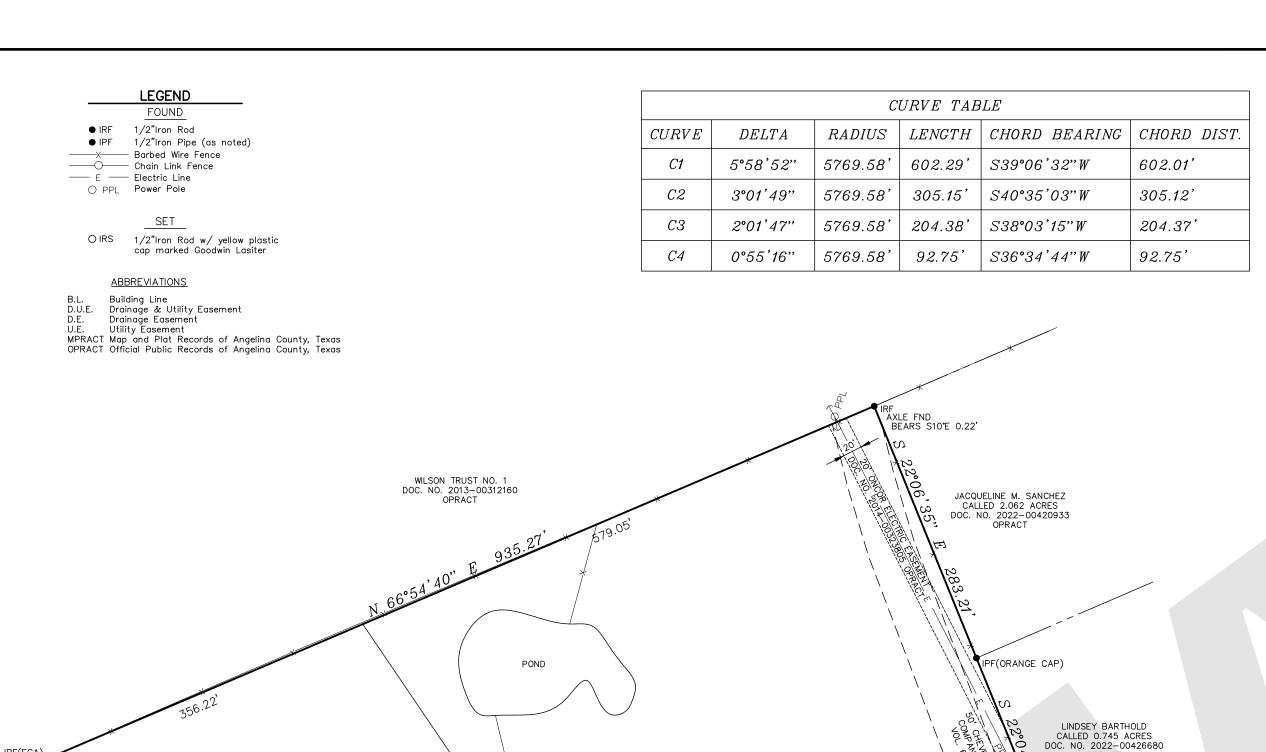

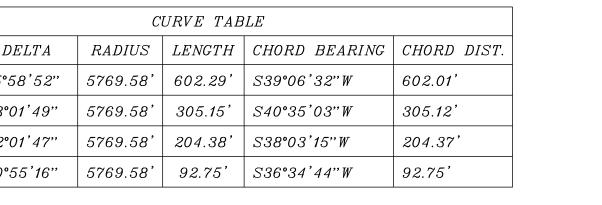

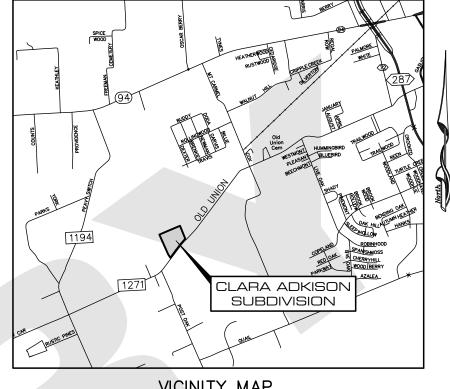

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

That I, Clara Anthony Adkison, owner do hereby adopt this plat designating the herein described property as Clara Adkison Subdivision, a subdivision to the City of Hudson, Texas, and do hereby dedicate, in fee simple, to the public use forever (except as noted) the streets and alleys shown thereon. The streets and alleys are dedicated for street purposes. The Easements and public use areas, as shown, are dedicated for the public use forever, for the purposes indicated on this plat. No buildings, fences, trees, shrubs, or other improvements or growths shall be constructed or placed upon, over or across the Easements as shown, except that landscape improvements may be placed in Landscape Easements, if approved by the City of Hudson. In addition, Utility Easements may also be used for mutual use and accommodation of all public utilities desiring to use or using the same unless the easement limits the use to particular utilities, said use by public utilities being subordinate to the Public's and City of Hudson's use thereof. The City of Hudson and public utility entities shall have the right to remove and keep removed all or parts of any buildings, fences, trees, shrubs or other improvements or growths which may in any way endanger or interfere with the construction, maintenance, or efficiency of their respective systems in said Easements. The City of Hudson and public utility entities shall at all times have the full right of Ingress and Egress to or from their respective easements for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining, reading meters, and adding to or removing all or parts of their respective systems without the necessity at any time procuring permission from anyone.
