RIGHT-OF-WAY EASEMENT

FOR: MARSHA & DAVID HAYES

We, the undersigned, for valuable consideration, the receipt of which is acknowledged, grant to **KIT CARSON ELECTRIC COOPERATIVE, INC.**, ("COOPERATIVE"), Taos, New Mexico, and to its successors or assigns, the right to enter upon the lands of the undersigned situated in Taos County, New Mexico: SEE ATTACHED

SURVEY & SITE PLAN. TRACT #: B-2B, 10.054 ACRES

and to construct, reconstruct, rephase, repair, operate and maintain on, across and under the lands or streets, roads or highways abutting said lands, an electric transmission or distribution line or system to cut, trim, and control the growth by machinery or otherwise of trees and shrubbery located within 5 feet of the centerline of the line or system (including any control of the growth of other vegetation in the right of way which may incidentally and necessarily result from the means of control employed); and to license, permit or otherwise agree to the joint use of occupancy of the line or system by any other person, association or corporation, for electrification, telephone purposes or cable television.

We covenant that we are the owners of the described lands and that the lands are free and clear of all encumbrances and liens except those held by the following person:

We agree that all poles, wires and other facilities including any main service entrance equipment, installed at the Cooperative's expense shall remain the property of the Cooperative, removable at the option of the Cooperative, upon termination of service to or on the lands.

In granting this easement, it is understood that the location of the poles will be such as to form the least possible interference to land use, so long as it does not materially increase the cost of construction.

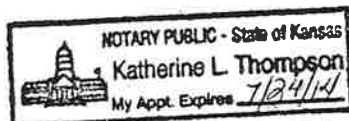
