(Previous Roof Repairs) all roof repairs to fix a few leaks occurred prior to having a new roof installed; new roof installed September 2025.

(Previous Other Structural Repairs) all exterior wall were sheathed with ½" OSB Plywood, wrapped in Hardie® Wrap Weather Barrier, *covered in Hardie® Plank, including soffits and fascia boards; replaced all interior and exterior doors; replaced floor decking in upstairs bathroom and front bedrooms; added headers above all windows and doors; added cross bracing on all exterior walls; installed 8 additional trusses to second floor; new sheetrock throughout with the exception of the living room; all structural repairs inspected and approved by City of Austin with the exception of the upstairs bathroom flooring

(Water Damage Not Due to a Flood Event) kitchen floor under refrigerator was damaged by water from a leaking refrigerator water line; floor decking was replaced

(Previous treatment for termites or WDI) 2014 termites were found in one wall of the living room (east side) and in the front porch header, and west wall of 1st upstairs bedroom. Damaged wood was replaced. Termites were exterminated by Bugmaster Pest Control. They continued preventive treatments annually until 2025.

(Previous termite or WDI damage repaired) 2014 termites were found in one wall of the living room (east side) and in the front porch header, and west wall of 1st upstairs bedroom. Damaged wood was replaced. Termites were exterminated by Bugmaster Pest Control. They continued preventive treatments annually until 2025.

(Previous Fires) Prior to 2014, fire from a candle began in the downstairs bedroom. A portion of the ceiling of that room and sections of the flooring in the bedrooms above it were damaged. All damaged areas were repaired: affected wood and electrical replaced. Repairs inspected by the City of Austin and approved.

"Flood pool" means the area adjacent to a reservoir that lies above the normal maximum operating level of the reservoir and that is subject to controlled inundation under the management of the United States Army Corps of Engineers.

"Reservoir" means a water impoundment project operated by the United States Army Corps of Engineers that is intended to retain water or delay the runoff of water in a designated surface area of land.
