

(Previous Roof Repairs) The roof was completely replaced in September 2021.

(Previous Other Structural Repairs) A small part of the front roof where the two slopes meet was adjusted to fix an original design issue that caused water to flow excessively down the wall during heavy rain. This adjustment successfully addressed the problem. Additionally, when we moved in during 2016, there was a leak near the chimney. The leak was fixed permanently, and the issue has been resolved.
